Synod Stated Meeting Presbyterian Mission Center | Irving, TX February 27, 2024

<u>Welcome & Introductions</u> –Synod Moderator Ben Davidson called the meeting to order at 1:00PM CT, opening the meeting with prayer.

<u>Acknowledgement of Land & People</u> – Vice Moderator Sharon Curry spoke of the Native American tribes that inhabited the land that is now Irving, Texas, offering a prayer of reconciliation and forgiveness.

Roll Call & Declaration of Quorum (*Attachment A*) – In accordance with the Bylaws, Sec. 3.1.3 whereby 50% or more of the elected commissioners constitutes a quorum, a quorum was declared by the Bridge Interim Synod Leader/Stated Clerk Steve Shive. 21 of 28 Commissioners were present.

<u>Seating of Corresponding Members & Visitors</u> (*Attachment A*) – Corresponding Members and Visitors were also acknowledged and seated. Seth Saathoff moved and David Watson seconded that the Corresponding Members and visitors by seated and given privileges of the floor. Motion carried.

Adoption of the Agenda (*Attachment B*) – With the meeting agenda presented, Polly Williams moved and Seth Saathoff seconded that the agenda be adopted. Motion carried.

Approval of Minutes (*Attachment C*) – Moderator Davidson presented the minutes from the Fall 2023 Synod Assembly, for approval. Without any additions or corrections, approval of the minutes for the Stated Meeting were moved by Seth Saathoff and seconded by David Watson. Motion carried.

<u>Introductions</u> – Synod Leader Steve Shive invited each participant to introduce themselves. A total of 56 participants attended this Assembly.

Worship – A contemplative worship experience was led by the Rev. Christopher Lee, Executive Presbyter of Grace Presbytery in the chapel of the Presbyterian Mission Center.

Synod Focus – Moderator Davidson outlined his vision for the 2024 year. Reading from two passages of the Gospels, Ben spoke of the great need in the world and the missions of the Synod that meet those needs. Ben encouraged the missions, ministries, and program to seek where the Spirit is leading us, taking bold steps.

<u>Celebration of Solar Under the Sun</u> (*Attachment D*) – Celebrating the transition of Solar Under the Sun from being a Network of the Synod to being a Covenant Partner. Steve Shive told the

story of Solar and gave thanks for this continuing ministry. Inviting board members forward, these friends talked about the mission and ministry and future of Solar Under the Sun.

Nominations – Moderator Davidson presented a list of names submitted by the Pan American School for their Board of Directors and Evergreen Life Services submitted a name to serve as their Synod Liaison:

Pan American School – Lemuel Garcia-Arroyo, Diana Freeman, Elizabeth Sinnet David Watson moved and Sharon Curry seconded that these names be approved by Assembly. Motion carried.

Evergreen Life Services – Jim Freeman

Polly Williams moved and Sharon Curry seconded that Jim Freeman be approved by Assembly. Motion carried.

Approval of 2024 Budget (*Attachment E*) – Coordinating Team Moderator Seth Saathoff and Treasurer Bill Wiles outlined the changes from the Preliminary Budget approved at the Fall 2023 Assembly. Bill also described the job of a Treasurer as not a gate-keeper, but as a partner in bringing resources together for the ministry of Jesus Christ. Bill reported our pros and cons for 2024:

Our Pros: The synod is financially sound, we have sufficient resources to do ministry, and we have an enthusiastic leadership.

Our Cons: We have a drop in giving from the Presbyteries and we have lots of places where we could be using our funds.

The Coordinating Team moved the acceptance of the 2024 budget. The motion passed.

<u>**Overtures to General Assembly**</u> (*Attachment F*) – Moderator Davidson presented the first Overture from Palo Duro Presbytery to GA to amend the Book of Order G-2.1002. Executive Presbyter Scott Campbell spoke to the concurrence. Sharon Curry moved and Seth Saathoff seconded that Synod of the Sun concur with this Overture. The motion passed.

Moderator Davidson presented the second Overture (*Attachment G*) to provide the list of counties of the geographic areas of each presbytery. Sharon Curry moved and Polly Williams seconded the motion. The motion passed.

<u>Election of the new Synod Leader/Stated Clerk</u> (*Attachment H*) – Rev. Jeff Cranton, Moderator of the Synod Leader/Stated Clerk Search Committee, presented his report. The Committee nominated the Rev. Michell Miller for this position. The terms of call were discussed. Questions from the Assembly were asked.

The Search Committee moved that Mitch Miller become our new Synod Leader/Stated Clerk. With great thanksgiving, the motion carried.

With gratitude, Jeff Cranton moved that the Search Committee be dismissed. The motion carried.

Announcements and Closing Prayer -

With the Assembly's business concluded, the Assembly gave thanks for the ministry and mission of Steve Shive in his time with us. With closing prayer by the Moderator, the Assembly goes forth doing the ministry and mission given to us by Jesus Christ.

Synod Stated Meeting Ferncliff Camp and Conference Center | Little Rock, AR October 17, 2023

<u>Welcome & Introductions</u> –Synod Moderator Seth Saathoff called the meeting to order at 9:30 a.m. CDT, opening the meeting with prayer.

<u>Acknowledgement of Land & People</u> – Moderator Saathoff acknowledged the Native American peoples who lived on the land that is now called Little Rock, including the Caddo, Quapaw, Osage, Choctaw, and Cherokee peoples. Even the name *Arkansas* came from the Quapaw people. Moderator called for a moment of silence to remember those peoples who called the land around Ferncliff home.

Roll Call & Declaration of Quorum – In accordance with the Bylaws, Sec. 3.1.3 whereby 50% or more of the elected commissioners constitutes a quorum, a quorum was declared by the Bridge Interim Synod Leader/Stated Clerk Steve Shive. 15 of 28 Commissioners were present (*Attachment A*).

<u>Seating of Corresponding Members & Visitors</u> – Corresponding Members and Visitors were also acknowledged and seated. Polly Williams moved and David Watson seconded that the Corresponding Members and visitors by seated and given privileges of the floor. Motion carried.

<u>Adoption of the Agenda</u> – With the meeting agenda presented, Ben Davidson moved and Ron Fike seconded that the agenda be adopted. Motion carried (*Attachment B*).

<u>Approval of Minutes</u> – Moderator Saathoff presented the minutes from the previous Synod Assembly on February 16, 2023, for approval. Without any additions or corrections, approval of the minutes for the Stated Meeting on October 2022 were moved by Ron Fike and seconded by Jim Freeman. Motion carried (*Attachment C*).

Bridge Interim Synod Leader/Stated Clerk Report – Synod Leader Steve Shive reported to the Assembly. Steve highlighted the process of evaluating the programs and missions of the Synod, visiting with Presbytery councils and Presbytery leadership. Steve also reported that the 2022 Presbytery minutes have been reviewed and reports sent to each presbytery.

Steve has begun coaching the three Oklahoma presbyteries, as they explore becoming a new creation. The Synod Leader/Stated Clerk search team has begun their work and Steve reported that the process is moving forward.

The Synod has started a program called "Living in Liminal Space" where an online conversation takes place with thought leaders about the future of the church. These conversations are also recorded and published on our Sunspots podcast.

Steve reported that Leaderwise and Boundaries Training has been established for four dates in 2024.

<u>Synod Moderator Report</u> – Moderator Seth Saathoff reported on how the churches, presbyteries and the Synod have changed since the last time we were able to meet in person. In our 'liminal' year, the Synod has transitioned leadership. While our year was not what we expected, Moderator Saathoff thinks that circumstances worked out for the best, maintaining what we have and setting us up to transition well to a new SL/SC.

Moderator Saathoff also reported of a sizable gift from the estate of Tyler Witt Aldridge of Baton Rouge. The Synod received a gift of \$1 million from this estate, along with gifts to his local church and the South Louisiana Presbytery and PC(USA) foundations.

Personnel Committee Report (Attachment D) – Committee Moderator Jeff Cranton reported that, with the recommendation of the SL/SC, the committee has assembled a Financial Oversight Committee to look over the finances of the Synod, clarifying our financial processes. Personnel Committee also proposed to the Coordinating Team the hiring of a part-time Administrative Assistant. The committee moved the approval of the new Administrative Assistant position. The motion carried.

Jeff also reported that the committee has oversight over the Synod Leader/Stated Clerk Search Team, reporting on the membership of the team. With the vision assessment, the team acquired the information they need to write the Ministry Discernment Profile. The search has now begun and candidates have submitted their names.

Jeff also reported that the Assistant Stated Clerk Ernie Higginbotham has announced his retirement, effective December 31, 2022. With regret and gratitude, the committee moved the acceptance of his resignation. Motion carried.

<u>Committee on Representation Report</u> (Attachment E) – Committee Moderator Rev. Minwoo Kim reported on behalf of the committee. The committee has been discovering their own role in the ministry of the Synod and how they can better communicate with the presbyteries. Minwoo also reported that this committee can serve as an 'intercultural committee', being a resource to churches who need support and guidance.

Empowering Committee Report (Attachment F) – Committee Moderator Wynona Bryant-Williams reported on behalf of the Committee. Wynona reported that the committee has spent the past couple of years discerning how they could use the \$20,000 gift given to each committee. After meeting with different ministry organizations, listening to their needs and concerns, the committee put out calls for proposals.

The Louisiana Organization for Refugees and immigration was awarded \$10,000 and the Global Ministry Committee of St. Charles Avenue Presbytery Church's Refugee Welcome Backpack Project was awarded \$2500.

<u>Coordinating Team Report</u> (Attachment G) – Coordinating Team Moderator Kristy Rodgers reported on actions taken by the CT on behalf of the Synod. Kristy spoke of the recent work of the CT, retelling some of the recent history of the practices and policies of the Synod.

Kristy brought the following actions taken by the CT to be affirmed by the Assembly:

Adoption of a new job description for Synod Leader/Stated Clerk position Adoption of Assessment and Visioning process for new leader search

Approved of a Disaster Relief grant of \$10,000 to Presbytery of Arkansas following tornadoes

Approved changing the Synod address to the Presbyterian Mission Center, located at 6100 Colwell Blvd. Ste. 200, Irving, Tx 75039.

Approved the creation of a Synod Financial Oversight Team to help develop a financial manual of operations that will capture and/or develop practices to help maintain continuity of operations, particularly during times of transition.

Approved remuneration for Bill Wiles' work on the Financial Oversight Team at a reduced CPA rate while we are in the process of sorting out these details and practices.

Approved the Synod Financial Oversight Team to develop and execute a plan for investing the Synod's idle cash funds into income generating financial vehicles including bank sweep accounts, certificates of deposit, money market funds, and the balanced equity fund offered by the Texas Presbyterian Foundation.

Approved that those authorized to be signers on these accounts will be Steve Shive, Kristy Rodgers, Seth Saathoff, Ben Davidson, and Bill Wiles, with the provision that it requires two signers to authorize any fund transfers or withdrawals.

Jeff Cranton moved to affirm these actions taken by the Coordinating Team, seconded by Ron Fike. Discussion followed. Motion carried.

The Financial Oversight Committee recommends to Assembly that a Certificate of Deposit with PILP that is renewable on October 28, 2023 at a higher rate of return be renewed. The CT moved that this CD be renewed. Polly Williams seconded. Discussion followed. Motion carried.

CT recommends the Stated Synod meeting for spring 2024 to be February 26-28, 2024, in New Orleans, LA. Motion carried.

Network Reports

Commissioner Kristy Rodgers reported on **Network for Dismantling Racism**, telling of their program "Resetting the Table" and their continued work of education and advocating.

Gary Holloman reported on **Synod Youth Workshop** (*Attachment H*), telling of this small groupbased event that takes place at the University of Tulsa. SYW has a 67-year history in our Synod.

Ruth Dwyer, new Coordinator for **Solar Under the Sun**, reported the on the work of SUTS to eliminate energy poverty all over the world. In order to apply for and receive grants from a larger donor base, SUTS has recently become its own 501(c)(3) organization, but will retain its close relationship with the Synod, including a designated board member from Synod of the Sun.

<u>Connecting Committee Report</u> (*Attachment I*) – Committee Moderator David Watson reported on that the committee is getting back to basic, focusing on its core mission. The committee is looking forward to engaging our Covenant Partners.

Equipping Committee Report (Attachment J) – Committee Moderator Maggie Alsup reported on behalf of the Committee, directing Commissioners to the packet for a full report.

Grants and Scholarship Commission Report (*Attachment K*) – Commission Moderator Sharon Curry reported on the work of the Grants and Scholarship Commission. So far in 2023, the Commission has awarded \$88,243.83 and anticipates awarding \$100k by the end of the year. Sharon outlined some of the ministries, missions, and programs that have been funded by G&S.

Synod Partnership for Disaster Response (Attachment L) – Kathy Lee-Cornell, Director of the Synod Partnership for Disaster Response, reported on the mission and ministry of SPDR. Kathy encouraged the Assembly to remember that she is the Synod's staff person to walk alongside presbyteries, churches, and groups to prepare for and respond to disasters. Over \$200k of PDA and SPDR funding has gone to disaster response in a coordinated fashion.

Dissolution of SCOOP – Synod Leader Steve Shive reported on the work of SCOOP, noting that this original committee was made up of members from all the Synod's presbyteries. It was noted from both General Assembly and other merged presbyteries that the effort to move forward should not be Synod-driven but come from the ground up.

The three Oklahoma presbyteries want to create their own group to bring proposals to their presbyteries, the Synod, and General Assembly. The Oklahoma Presbyteries Task Force has been formed.

It is recommended that SCOOP be dismissed, with the gratitude for the groundwork that they have laid, so that the new task force and be tasked with bringing forth the new creation. Jeff Cranton moved, and Jim Freeman seconded that SCOOP be dissolved. Motion carried.

<u>Amendment of Synod Bylaws</u> (Attachment M) – Synod Vice Moderator Ben Davidson began the discussion of amending the Bylaws. Ben moved that we suspend article 3.2 of the Synod Bylaws to allow Sharon Curry and Kristy Rodgers to serve as At-Large Commissioners for a third term, allowing Sharon to serve as Vice Moderator of the Synod for 2024. The motion also includes sending back to the Committee on Representation the motion to amend the Bylaws to

make room for additional persons to be included at At-Large Commissioners. David Watson seconded. Motion carried.

Nominations (Attachment N) – Synod Vice Moderator Ben Davidson reported on the work Synod Committee on Representation, presenting a slate of candidates to serve the Synod in 2024. Nominees for Diversity Representation, Committee Leadership, Standing Committees, Financial Leadership, and Synod Leadership were presented. The slate was elected.

The following candidates for leadership for Covenant Partners were listed: Presbytery Foundation of Louisiana Board of Trustees Class of 2025, James CJ Young, St. Charles Ave. Presbyterian Church Class of 2024, F. David Grisset, St. Charles Ave. Presbyterian Church Class of 2024, Betty Henderson, First Presbyterian Church, Shreveport Class of 2023, Piper Morris, First Presbyterian Church, Shreveport Class of 2023, Patty Kennel, St. Charles Ave. Presbyterian Church

Board of Trustees Lyon College Victor Worley, Little Rock, AR Gary Paxon , Batesville, AR John Bellar, Cave City, AR

The slate was elected.

<u>Approval of Preliminary Budget</u> (*Attachment O*) – CT Moderator Kristy Rodgers presented the Preliminary Budget for 2024. Kristy highlighted some of the line items in the budget for the Assembly. The budget was approved.

<u>Approval of SPDR Budget</u> (*Attachment P*) – CT Moderator Kristy Rodgers presented the Preliminary Budget for SPDR for 2024. The budget was approved.

With the Assembly's business concluded, the Assembly then moved to the installation of the 2024 Moderator and Vice Moderator.


SUS History:

Established in 2009, Solar Under the Sun emerged from the awareness within our sister organization, Living Waters for the World, of the profound consequences of energy poverty on essential aspects of life—clean water, education, and economic equity. With its close ties to the Presbyterian Church (USA), it was originally organized under the auspices of the Synod of the Sun (PCUSA's regional governing body encompassing Arkansas, Louisiana, Texas, and Oklahoma.)

Under the visionary guidance of Chris McRae, our inaugural Executive Director, a dedicated team of talented individuals came together to spearhead this endeavor. This collaboration first bore fruit in July of 2009 with the installation of a solar-powered clean water system at the St. Thomas Episcopal Parish in Arcahaie, Haiti. Furthermore, it began to scale its impact in May of 2010, with the first Solar Under the Sun training session at Ferncliff Camp and Conference Center outside of Little Rock, Arkansas.

Since its inception, SUS has held twenty-four Solar schools (including one in Puerto Rico) and trained a diverse array of individuals with backgrounds that include technology, education, community development, family management, health, and business. These trained individuals have subsequently gone on to execute over 170 projects spanning 7 countries across three continents, creating a lasting impact in the realm of sustainable energy solutions for those in energy poverty.

Overture: Regarding Clarifying the Intent of G-2.1001 on Use of Commissioned Pastors

RECOMMENDATION

The Presbytery of Palo Duro overtures the 226th General Assembly (2024) to direct the Stated Clerk to send the following proposed amendment to the presbyteries for their affirmative or negative votes:

To amend Book of Order G-2.1002 to allow commissioned pastors by amending G-2.1001, Book of Order to read:

G-2.10 Commissioning Ruling Elders To Particular Pastoral Service

G-2.1002 Training, Examination and Commissioning¹

A ruling elder who seeks to serve under the terms of G-2.1001 shall receive such preparation and instruction as determined by the presbytery to be appropriate to the particular commission. Such preparation shall include a certificate of completion of boundary training, which includes the topic of sexual misconduct, and child sexual abuse prevention training with recertification at least every thirty-six months. The presbytery shall determine which training courses are approved to meet the criteria of these two requirements. The ruling elder shall be examined by the presbytery as to personal faith, motives for seeking the commission, and the areas of instruction determined by presbytery. A ruling elder who has been commissioned and later ceases to serve in the specified ministry may continue to be listed as available to serve but is not and is authorized to perform the functions specified in G-2.1001 until commissioned again to a congregation or ministry by the presbytery subject to annual review by the presbytery. The Commissioned Pastor will carry voice and vote as Commissioned Pastor while they continue their life in the presbytery.

Rationale

The General Assembly amended G-2.1001 in 2022 to clarify that a ruling elder could serve as Commissioned Pastor (CP) to multiple worshipping communities or missions in the presbytery, subject to approval of the presbytery and the appropriate sessions. This is a recognition by the denomination of the growing importance of the CP. Commissioning a CP for service in multiple congregations or other ministries is a frequent practice in the PCUSA.

CPs provide faithful service to our denomination and with their gifts provide service to congregations that might otherwise go unserved. It makes sense to allow the use of the gifts in as broad a venue as possible. Through this change in the Book of Order, presbyteries, churches and CPs will benefit in many ways. Some instances of that are:

- Some who are serving churches as lay leaders have expressed an interest in becoming a CP but have not pursued that path because they want to serve more than one church. By this change, the call to become a CP may attract a larger number of candidates.
- 2. CPs who are not currently commissioned to a church are ready on the quick to fill empty pulpits provide as pool of CPs ready on the quick to fill empty pulpits.
- Because of the expanded role of a CP, congregations will more likely opt for a CP in small, chronic empty pulpits in rural areas when a teaching elder is not available. Hopefully, the congregations will see the advantage of a trained pastor who will be readily available.
- 4. This change is consistent with the Presbyterian call to those who are called to be proclaimers of the word.
- 5. This change lifts the title, the calling and the professionalism of this role from location to location.
- 6. CPs gain experience and wisdom that can be shared at presbytery and council meetings.

Rationale

In 2021 the Office of the General Assembly initiated a project to develop a database with the descriptions of each presbytery's geographic district, as well as a precise and accurate map. When the process revealed a variety of discrepancies and needs for clarification, OGA had conversations with mid council leaders in every synod to resolve identified issues. Agreements developed during those consultations resulted in these clear descriptions, now presented to the General Assembly for approval.



Synod Partnership for Disaster Recovery

Synod of the Sun Assembly February 2024 Report

The SPDR Leadership Group consists of Jim Kirk (2022), Presbyterian Disaster Assistance; Matt Miles (2022), Tres Rios Presbytery; Cheryl Pennington (2024), Indian Nations Presbytery; Stewart Smith (2024), Presbytery of Arkansas; Richard Williams (2022), Presbytery of South Louisiana; and Steve Shive (2023), Interim Bridge Synod Leader and Stated Clerk, Synod of the Sun.

The Leadership Group met in-person on November 28-30, 2024 to present to the EP Forum SPDR's activities and accomplishments in 2023, as well as to conduct a review of the partnership and to identify partnership goals for 2024. **The 2024 SPDR goals are to:**

- Refine and clarify the responsibilities of PDA, SPDR and its Leadership Group, Presbytery Liaisons, and local Presbytery disaster committees/task forces in times of disasters
- Develop and organize workshops and training events for presbyteries and congregations, with particular emphasis on emotional/spiritual care, Long Term Recovery, and how individuals can engage in disaster response and recovery,
- Enhance the communication and storytelling of SPDR, and
- Create and implement a Synod event designed for Presbytery Liaisons and Presbytery disaster committees/task forces to strengthen disaster preparedness, response and recovery capacities

SPDR Director's Report: 2024 has already tested our SPDR network with several severe storm systems and arctic weather impacting several presbyteries. On February 7th, Eastern Oklahoma Presbytery applied for a Church Damage Grant to PDA to support St. James PC (Jenks, OK) who suffered water damage from a burst pipe.

The SPDR Presbytery Liaison's Team met last month and began discussions of an in-person Training/Retreat event in the Fall to strengthen the Liaison Team's relationships and capacity to serve Synods and Presbyteries through SPDR.

A new **12 Step Guide to Building Resiliency** was released in January with additional resources, podcasts, and more social media content to come, designed to inspire disaster preparedness and response activities with congregational and presbytery leaders.

REPORT / INFORME

2024 marks the **10th Anniversary** of the Hispanic Ministries Mission Network (HMMN) as a validated Network of the Synod of the Sun. And it is with gratitude to God Almighty for this first decade of challenges, discernments, learnings, and blessings.

BEGININGS

In 2014, under the guidance of the Reverend Rubén Armendáriz (HR), a team of Hispanic leaders started a process to reorganize the former *Hispanic American Ministries Council* (HAMC) into the Network structure required by the Synod of the Sun for the new relationship with its Racial Ethnic constituencies. The planning process produced a goals and objectives document in which the Austin Presbyterian Theological Seminary became the institution providing the logistic support for HMMN events and financial administration through its Education Beyond the Walls Office.

MEETINGS and EVENTS

Annual Convocations at the Austin Presbyterian Theological Seminary Campus have been held in the spring of 2016, 2017, 2018, 2019, 2020 (canceled due to the pandemic), 2021 (virtual), and the fall of 2022. 2023 was skipped due to logistical challenges as churches came out of COVID. Our 2024 meeting is happening Friday the 8th and Saturday the 9th of March 2024. The Rev. Dr. Daniel Beteta (HR) and Dr. Patricia Bonilla, Austin Seminary Christian Education Assistant Professor, are our 2024 Keynote speakers.

Every year, keynote speakers and lectures have been given by General Assembly staff and former Co-Moderators, Seminary Professors, as well as National and Regional Hispanic Leaders. HMMN *by-Laws* were updated in 2021 and formally approved in 2022 when the co-moderators leadership model was adopted. HMMN is very grateful to the Synod of the Sun for its financial, administrative, and spiritual support.

CHALLENGES and HOPES

Hispanic Ministries in the Synod of the Sun are concentrated in the Texas Presbyteries of Mission, Grace, New Covenant, and Tres Rios.-To date there are no validated Hispanic Ministries in the Presbyteries of Palo Duro, Cimarron, Indian Nations, Eastern Oklahoma, Arkansas, Pines, and South Louisiana. However in Texas, during the past decade the number of Hispanic Congregations and Ordained Active Pastors has decreased, with Ordained Pastors being replaced, in some cases by Commissioned Lay Pastors. Nevertheless, our Network is a beacon of hope to current Hispanic Leaders for a future of spiritual and numerical growth.

EXPECTATIONS from THE SYNOD of THE SUN

HMMN encourages the Synod to be more intentional in supporting all its validated Networks, especially by enhancing and creating collaboration opportunities between Synod Racial Ethnic Networks. HMMN encourages the Synod to be more proactive, through its Presbyteries, in the sustainability of existing Hispanic Congregations as well as projecting new Hispanic Latino outreach within its bounds. HMMN joins You in lifting up the Synod's many ministries, networks and programs in prayer, and welcomes the opportunity to share its experiences and "know how" throughout the Synod
